The Vestry of St. Anne's

Resolution on 2021 Housing Allowance for the Rev. Thomas A. Lacy, II

Whereas, section 107 of the Internal Revenue Code specifies that the amount of ministers' compensation that is designated in advance by their employer as a housing allowance is not taxable in computing federal income taxes to the extent that it is used to pay for actual expenses incurred in owning or renting a home or apartment, and, in the case of ministers who own their home, does not exceed the fair rental value and maintenance of the home; and

Whereas, the Rev. Thomas A. Lacy, II is compensated by St. Anne's Episcopal Church exclusively for services as a minister; and

Whereas, St. Anne's Episcopal Church does not provide the Rev. Thomas A. Lacy, II with a parsonage; therefore, it is

Resolved, that the total compensation paid to the Rev. Thomas A. Lacy, II for calendar year 2021 shall be \$72,047.88, of which \$28,819.15 is hereby designated as a housing allowance pursuant to section 107 of the Internal Revenue Code; and it is further

Resolved, that the designation of \$28,819.15 of the Rev. Lacy's annual compensation as a housing allowance also shall apply to all future years that the Rev. Lacy is employed by St. Anne's Episcopal Church, unless otherwise provided.
